

**Superior Hypogastric Plexus Block** 

ra de	This procedure is done to diagnose and treat pelvic and genital pain (pain from endometriosis,
co	adiation injury, tumors, pain from the bladder, urethra, vagina, uterus, prostate, testes, penis, the escending colon and the rectum). Nerves that serve this area are located in front of the spinal olumn. Sometimes more than one block is needed to achieve maximum benefit.
lo pl co a s	You will be asked to lie face down on a cushioned x-ray table. A small needle is used to inject a local anesthetic into the areas around the injection site to numb the skin. Next, a long thin needle is laced in the side of the lower back and advanced to the front of the spinal column; placement is confirmed with the fluoroscope and injection of contrast dye. After placement of one or two needles solution of local anesthetic is injected. The medication will travel through the spinal column to the sympathetic nerves in the pelvic region. The needles are removed and small band aids are applied.
preparation? in no FG	You may receive conscious sedation. Conscious sedation is a medication given through an intravenous (IV) catheter (tube) in a vein in your arm. The medication will help you relax, but it will ot put you to sleep. If you opt to have conscious sedation, you MUST NOT EAT OR DRINK OR 4 hours before your procedure. However, you may take your medication with a small sip f water. You must have someone available to drive you home after the procedure.
What to wear?	lease wear loose, comfortable clothing and leave all jewelry/other valuables at home
	We ask that you arrive 30-45 minutes before the scheduled time of your procedure. The procedure asts about 15-30 minutes, and you will be in the recovery room about 15 minutes.
	Pain in the area where the needle(s) was inserted. The pain can last for two to three days and can e treated by using ice and mild analgesics (pain medication) such as Motrin, Naprosyn or Tylenol
aı	A reaction to the contrast dye. These reactions usually do not require further treatment. However, reaction to contrast dye may result in sneezing, hives, swelling of the face, and throat, respiratory ifficulties and shock. Medication and/or respiratory assistance may be required.
	Allergic reaction to the local anesthetic or conscious sedation, including but not limited to: emporary numbness or weakness in both legs. This is normal. You should not drive for 24 hours
*	Bleeding, bruising, or infection in the injection area
*	Dizziness, increased pain
*	Nerve damage, paralysis, stroke and even death

## INSTRUCTIONS REGARDING YOUR PROCEDURE Superior Hypogastric Block

Will I receive a pre-procedure phone call?	A nurse from our office will call you 24-48 hours prior to your procedure. She will ask you a few important medical questions, <u>AND</u> she will confirm your appointment. We must have <u>a verbal confirmation from you 24-48 hours prior to your procedure.</u> Failure to return our call could result in your procedure being rescheduled.
Where can I obtain more procedure information?	Please visit our website <u>www.nyspineandwellness.com</u> . It contains demonstrations of some of the procedures we offer. We also have other helpful information.
Can I drive home from the procedure?	You MUST have a ride home, and your driver should remain on site. You must not drive or operate heavy machinery for 24 hours.
Can I eat Breakfast? *the box with a check applies to you	Yes, you can eat a light breakfast or light lunch
	No, <b>DO NOT EAT OR DRINK</b> for <b>4</b> hours before your procedure. However, you may take your medicine but only with a <b>small sip of water</b> .
Should I stop taking aspirin?	If you take ASPIRIN or products containing ASPIRIN in doses greater than 325 mg/per day, you must stop taking it 7 days prior to your procedure (examples of ASPIRIN-containing products include but are not limited to: EXCEDRIN, FIORINAL, AND ALKA SELTZER, etc).
Can I take the aspirin prescribed for <u>cardiac</u> and or <u>stroke</u> prevention?	Yes, <b>HOWEVER</b> , limit the daily dose to 81 mgs per day for the 7 days prior to the day of the procedure.
Can I take my blood thinner? *the box with a check applies to you	<ul> <li>Our provider has advised you on the number of days to hold the blood thinner you take.</li> <li>Our provider will have to contact the Doctor who has prescribed the blood thinner for you to learn how long it is safe for you to be off the medicine prior to your procedure. One of our nurses will call you when we have obtained that information.</li> </ul>
Can I take my other medications?  *the box with a check applies to you	Yes, except for blood thinners.  Yes, only with a small sip of water, (you must not take your blood thinner)
What time is my procedure?	You will receive a phone call one or two business days prior to your procedure to remind you of the time you should arrive for your procedure (usually 30-40 minutes prior to the scheduled time) and the location. <b>PLEASE BE ON TIME.</b> *some patients may receive a call to confirm insurance information.
How long will it take?	We ask that you plan $1\%$ -3 hours from the time you arrive at the center to the time you are discharged. Please understand that circumstances sometimes arise that are out of our control, which cause a longer delay. Please plan accordingly.
What do I bring?	You <i>must</i> bring the following <u>each time</u> you have a procedure:  1. Your current insurance information  2. A <i>written</i> list of all your current medications <u>including the strength and frequency</u> you take them. Please include over the counter medication, vitamins and herbal supplements.
What shall I wear?	Please wear comfortable loose fitting clothing.
Can I wear jewelry?	No. Please leave all jewelry and other valuables at home. We are unable to store them safely. Any body- piercing jewelry must be completely removed, as this may interfere with the x-ray machine.
What do I do if I am ill or have to cancel?	Please call the office 24 hours in advance, if you are unable to keep your appointment. (315) 552-6700. We do charge patients for no shows.
